

Volunteering Encourages Employees to Connect with Each Other — and Their Jobs

Want your team to feel better and work better? Create a volunteer program.

But there has been little agreement among experts on why this should be the case.

Recently, however, Professors Jeffrey Pfeffer and Sara Singer of the Stanford Graduate School of Business analyzed survey data from hundreds of businesses in the United Kingdom to tease out the mechanisms through which volunteering improves both employee health and organizational outcomes. (The data was collected through Britain's Healthiest

Workplace and includes more than 53,000 employee responses.)

Their research, which appears in the Journal of Environmental and Occupational Medicine, suggests that company-sponsored volunteering works its two-pronged magic by boosting social bonding among coworkers and creating a sense of identification between employees and employers.



The findings could help businesses figure out how to build better volunteer programs and encourage more employees to participate in them. And that would be good for everyone.

What prompted this study?

Sara Singer: We came to this work because we were interested in what employers could do to enhance employee health and the ways in which that benefits employers themselves. We weren't interested in volunteering per se, but volunteering emerged as a promising vehicle for enhancing employee health with positive benefits to employers.

There had been a lot of work that demonstrated that volunteering has lots of positive benefits, but the question was why? We posited social bonding with coworkers and identification with employers as two mediating factors.

Are you hoping to prompt more employers to sponsor volunteering programs?

Singer: Employer-sponsored volunteer programs are pretty widespread; it's just that the uptake isn't very high. The challenge is really in creating programs that encourage people to participate. You've got to make opportunities for things that employees want to participate in because they provide meaning and purpose. You have to provide the flexibility that allows them the time to do it. Creating the conditions that allow employees to participate in company-sponsored volunteering programs is key.

What led you to believe that volunteering might improve employees' physical and mental health by increasing their sense of social connectedness?

Jeffrey Pfeffer: We know from a lot of other research — and we know from what's happened with COVID — that social isolation is harmful for mental and physical health, and social connection is helpful for physical and mental health.

What does it mean for an employee to identify with their employer?

Singer: The survey uses a scale that talks about feelings of belonging in the organization, recommending one's organization as a place to work, and sharing the values and goals of the organization.

Is volunteering the only means of achieving these effects?

Singer: Volunteering is one way to do it, but you can create opportunities for social bonding through work teams. And there are other ways of building identification with businesses, like branding.

Employers shouldn't take away just that they have to have robust volunteer programs, although we hope that they do. They should also take away that they should work on efforts to build coworker ties through creating great teams and social activities for their employees.

But if they do create volunteering opportunities, they need to pay attention to these mechanisms, right?



Singer: In order to achieve the benefits, they need to find ways of having volunteerism build coworker ties and identification with the company. Otherwise, it won't achieve its purpose.

Pfeffer: If Stanford lets Sara volunteer but that volunteering occurs with Sara doing it on her own, you will not get the advantages of social bonding.

If you want to get the advantages of social bonding, then you want to have volunteer programs where people volunteer as a group or as a team, as opposed to just saying, "Go off and spend some time working on Planned Parenthood," or whatever. That would not get you the same level of benefit as saying, "We are going to organize collective volunteer activities in which we are going to work together" — which of course is going to increase social bonding as opposed to doing it by yourself.

You also point out that the positive impact of volunteering depends on the degree to which employers support it. Singer: How your individual manager responds when you come back to the office and say that you volunteered can actually make a big difference. And there's a huge range of ways that employers can promote volunteer work, from sponsoring and publicizing the activity to organizing the activity in a way that people feel like they are being encouraged to participate and engage in it.

You also suggest that volunteering might help overcome "digital disadvantage," whereby remote and hybrid workers suffer in terms of pay and career progression because they are less visible. That would seem to be especially important now that the pandemic has accelerated the shift to remote work.

Pfeffer: Absolutely. But again, it depends on how the volunteering opportunities are designed. If you design volunteering to be by Zoom, you're not going to have the same effect as if you design it to be in person.

How Midsize Companies Can Keep Up with Al

Summary.

Right now, many businesses are reacting to generative AI in a vacuum. But individual innovations shouldn't be approached with a narrow, short-term focus, as midsize companies that chase each new trend will find themselves over-committed and underprepared when that trend wears off. Instead, zoom out. How does this current innovation build on the technology already in place, and what can we expect it to build toward in the future? A wider, long-term view will bring much-needed perspective at a time when many are being swept up in the attention AI is getting.

What do the internet, smartphones, social media, the metaverse, and generative AI have in common?

Answer: they're all part of the same, ongoing innovation movie.

We've seen this movie before, and if the Fast & Furious series can create double-digit sequels

(movie number 10 coming soon), we should expect the same from technology.

Somehow, we keep forgetting, but this current Al hype cycle isn't the first, and certainly won't be the last. Innovation is exciting, but it's also ongoing. Just when we started figuring out the internet, along



came smartphones. As the metaverse grabbed our attention, generative AI arrived. While we're all still navigating both the ethical and safety concerns, if this truly is generative AI's smartphone moment, then another innovation will have its own generative AI moment. It's not a coincidence; it's a never-ending pattern. Rinse and repeat.

How can leaders make sense of it all? Those at midsize companies face this obstacle from a unique perspective. Their size and agility allow them to mobilize more quickly to understand generative Al's capabilities and how to optimize them for maximum organizational benefits. However, midsize companies have their limits when it comes to resources and how much they're able to scale. To combat these challenges, research suggests that midsize companies lean into an ecosystem of partners to compete with large enterprises in the fast-paced world of Al. Gaining access to the right talent, data, and ideas is critical.

But at this point, the disruption that is generative Al shouldn't have come as a shock. Midsize companies are not immune to groundbreaking technology; it's something they should anticipate. The only questions are what the next one will be, what it will do, and how they will use it.

Constant change is now the expectation, and it's almost impossible to keep up. But I believe middle-market leaders can make sense of this latest AI craze by creating a culture of adaptability. Here are three things they should keep in mind as they aim to accomplish it:

Avoid a Narrow, Short-Term Focus

Right now, many businesses are reacting to generative Al in a vacuum. But individual innovations shouldn't be approached with a narrow, short-term focus, as midsize companies that chase each new

trend will find themselves over-committed and under-prepared when that trend wears off. Instead, zoom out. How does this current innovation build on the technology already in place, and what can we expect it to build toward in the future? A wider, long-term view will bring much-needed perspective at a time when many are being swept up in the attention Al is getting.

Adaptability = Resiliency

When we talk about future-proofing for the next big disruption, that starts with adaptability, as midsize organizations that are versatile in the face of ongoing change are also resilient. It's not about tying everything to one particular disruptive moment; it's about becoming an organization that thrives in the face of disruption because you have become so flexible that it doesn't faze you. The rate of change is accelerating, with the pace of AI growth now exceeding Moore's Law. Midsize companies that are architected to transform and prepared to pivot relish in these moments because they provide a competitive advantage. Middle-market leaders who connect adaptability to resiliency not only gain this advantage, but their organizations also avoid surprises and are built to last. It may sound simple but getting back to business basics can bring enormous value in these moments.

There Will Be Another ChatGPT

As revolutionary as it may be right now, more innovation is coming that will make generative Al seem obsolete. Don't ask yourself how you'll modify your business today to maximize the capabilities of ChatGPT. Instead, ask yourself how you'll create the foundation now so your business can quickly adjust for every other ChatGPT (and new version of it) that's still to come. It might feel like these innovations burst onto the scene, but they're in development for years.



It's impossible to predict the future (even AI can't do that, although it tries), but those midsize companies that are paying attention can anticipate the next big thing. By understanding the long historical context of innovation cycles, leaders should recognize that this journey does not have a finish line and is likely to repeat.


In the current tech landscape, experiencing déjà vu each time there's buzz around a new technology is a normal (perhaps even healthy) response. Recalling the continuous cycle of innovative breakthroughs we've witnessed over the years can hopefully bring mid-market leaders a sense of calm and clarity. Through a big-picture focus and an emphasis on future-proofing for the next disruptions with a culture of adaptability, midsize organizations can tackle whatever challenges may come their way. It's a crazy time, but we've seen this movie before. And the series is far from over.








Meeting
