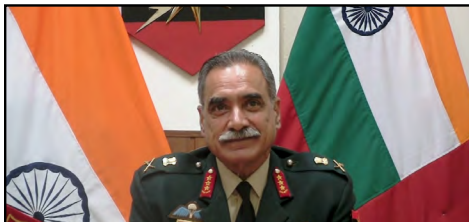

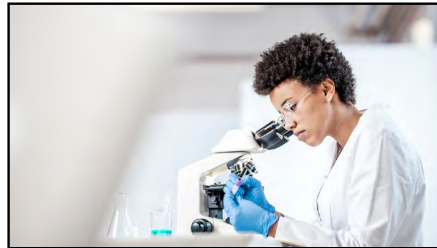

Transformation for Continuity

AIMA held its 65th Foundation Day & 15th National Management Day online on the theme 'Transformation for Continuity' on 20th February 2021. Ms Nirmala Sitharaman, Minister of Corporate Affairs & Finance, Government of India delivered the keynote address and said that the Indian economy had great demand for steel, copper, coal etc and the PSUs needed to be run more efficiently and productively to meet that demand. "We are not selling PSUs for closure. We want them to be run better," she said. She urged AIMA to nudge Indian business into investing and expanding capacity.

Ms Nirmala Sitharaman emphasised that the government was committed to multi-year stimulus spending to support sustained economic recovery. She asserted that this year’s budget was about charting a clear and certain path for the next decade. “Each word

of this budget is full of meaning, so make the best use of it,” she told the management leadership of the country.

Mr Uday Kotak, Executive Vice Chairman & Managing Director, Kotak Mahindra Bank, who also addressed

the management leadership of the country on the occasion, asked his peers to do more than just applaud the government. “Time has come for Indian business leaders to walk the talk,” he said. Mr Kotak asserted that India needed to get covid vaccination done as soon as possible and move into the post-covid era quickly. He

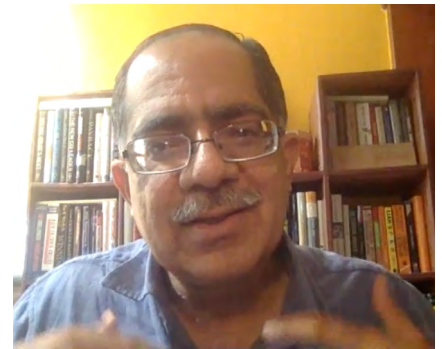

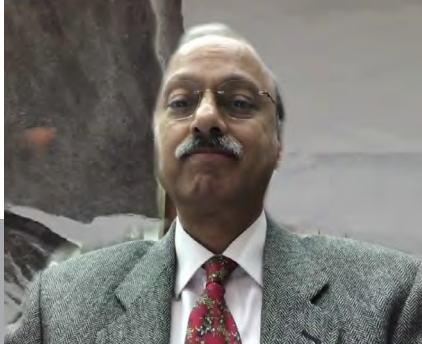

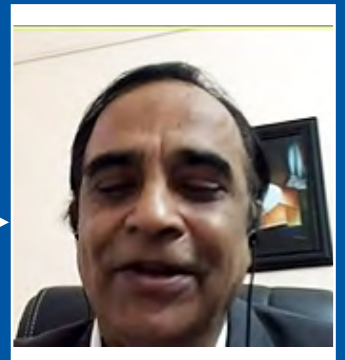

Creative pangs

DEVINDER SETH is a successful chap - at least by the usual yardsticks of society. A fairly senior business executive enjoying all the frills of a high profile corporate job - decent salary, furnished house, car & chauffeur, entertainment and foreign jaunts. An accomplished wife and smart children making up the family, it is an enviable existence by any reckoning.

Occasionally, he dabbles in creativity through little harmless forays into writing, speaking, photography etc. To his credit are minor successes like letters to the editor or an article here and there, mostly in professional journals. The scrap book, however worthless, keeps getting thicker.

A few well-prepared talks are repeated with monotonous regularity in different fora. Even with the usual clichés and borrowed lines these speeches did not exactly make him a forceful orator. Then the same talks would be typed out as articles and sent to all possible publications - unmindful of the pile of rejection slips.

Secretly he envied all those prolific speakers at the management seminars-the ease with which they delivered long talks, their seemingly effortless participation in panel discussions and extempore addresses. He thought a lot about those lucky authors whose charming little pieces appeared as middles in the major dailies. Their style, the fluidity of words and phrases, the subtle humour were all so distant, so ethereal to him. Then there were the regular contributors to the financial papers - writing scientifically researched articles on issues of national importance. His greatest desire was to become a prolific writer one day. But he knew it would remain just a dream.

Then something happened. The editor of a well known glossy met him at a party and agreed to look at one of his professional articles. She even asked for several colour transparencies. Our budding writer-cum-photographer was in seventh heaven. The write-up related to rural life. Several rolls of film were exposed; early morning visits to the country side, furious hunt for the right shots, consultations with friends regarding technically superior pictures, snubs from rural women misunderstanding the motives were all part of the game. Somehow the job was completed and the article with slides was, sent to the magazine's editor. As if by magic, it actually appeared in print few months later.

There was no end to our hero's joy. He started day-dreaming. His ambition now didn't appear all that distant, it seemed within reach. He was going to make it. A sense of happiness

enveloped him as he sat in his office contemplating the vistas opening up.

He saw the announcement of a photo-feature, in a popular fortnightly, inviting black & white pictures depicting 'India with a touch of humour'. The first few issues carried pictures by celebrated photographers - they all looked so simple. Suddenly his passion was black and white photography.

Traffic intersections, birth control hoardings, 'dabba brigade' - poor people going to answer the call of nature in open air - monkeys, bears with trainers, bullock carts... everything looked typically Indian and humorous. Twenty enlarged pictures were duly dispatched and next thing he saw was a letter accepting all of them. They even decided to publish these in a special edition with accolades for the budding new photo-journalist - a new force on the scene - someone to be watched.

All of a sudden there were requests pouring in for his photo essays, offers to commission him for special projects. Even some international magazine wrote to ask for contributions to be paid \$500 per picture. What came next was even better. He was much in demand at various management workshops. His talks were greatly appreciated - full of witty remarks and appropriate anecdotes.

He talked practical sense, not the bookish stuff of those visiting professors. His speeches were quoted. His articles generated tremendous response and debate. There were no more rejection slips. He was invited to many panel discussions on TV and commanded respect. Business schools vied with each other to include him on their faculty.

Then he was writing middles for newspapers. Their well-known authors were no more the distant heroes. They were his fellow writers. His pieces were actually better; infinitely more interesting, urbane and literary. He had arrived. He had become a writer.

Suddenly he was jolted from his pleasant reverie. His phone was ringing incessantly. It was his wife calling from home - another bunch of rejections had arrived and she wanted to know when he was going to give up this madness!

Making the Hybrid Workplace Fair

Summary.

Thanks to the benefits for both employers and employees, hybrid work arrangements will likely persist beyond the pandemic. In order for them to work, though, leaders must understand the power differentials they create within teams and take steps to level the playing field. Where individuals (including the manager) on a team are located relative to others matters, as does each individual's skills in relationship building. The authors offer four strategies managers can take to manage the structurally inevitable differences in power that arise in a hybrid environment. Not doing so can damage relationships, impede effective collaboration, and ultimately reduce performance

The pandemic has upended much about how we work, and what comes next is neither the death of the office nor a return to the way things were. Instead, our new reality will be hybridity: working with employees who are co-located in the same physical space as well as employees working remotely.

Hybridity promises organizations the benefits of remote working (increased flexibility, reduced carbon footprint, labor-cost optimization, and increased employee satisfaction) alongside the critical strengths of traditional, co-located work (smoother coordination, informal networking, stronger cultural

socialization, greater creativity, and face-to-face collaboration). But hybridity is also inextricably tied to power — it creates power differentials within teams that can damage relationships, impede effective collaboration, and ultimately reduce performance. To lead effectively in a hybrid environment, managers must recognize and actively manage the two distinct sources of power that can impede — or facilitate — hybrid work: hybridity positioning and hybridity competence.

How Hybridity Positioning Affects Power

First, hybridity means that, due to where they're positioned, employees have different access to resources and different levels of visibility — both key sources of power and influence.

Resource access differs depending on whether the employee is located in the office or outside of it. Employees in the office have ready and quick access to technology and infrastructure to support their work. They tend to have faster and easier access to information, and that information tends to be more current and broad (including informal water-cooler conversations), which provides them with an edge when it comes to the rapid changes of today's environment. Being in the office also provides access to the emotional and task-based social support provided by peers.

In contrast, employees who work remotely often find their weaker technological setup and infrastructure (slow connections, inability to access certain resources from home, a less sophisticated home office setup) makes it more difficult to demonstrate their competence. Not being present for informal interactions leaves remote workers feeling out of the loop and last to know. Being remote may also lead employees to feel more isolated and lacking the relationships and connections that provide social support.

Visibility level, or being seen by those in power, is also shaped by an employee's location — especially their location relative to their boss and senior managers. Working in the same space as the boss increases the likelihood that employees' efforts and actions will be recognized and top of mind. Employees who are seen in the hallways are likely to come to mind when it's time to staff an important new project, and their actions on that project are likely to be recognized, resulting in credit for a job well done. Even if the boss is working remotely, when an employee is based in the office, it increases the likelihood that their actions will be seen by others and reported to the boss indirectly. When working remotely, no one sees the late nights or early mornings or how hard employees are working to deliver on their obligations. Credit for a collective output is likely to be unevenly attributed most to those who are there in the office and more visible.

Taking these two dimensions of hybridity positioning together, we can understand how hybridity affects each employee in a team or work group by thinking in terms of where the employee and manager are situated.

How Hybridity Competence Affects Power

Not all individuals are equally skilled at operating within a hybrid environment. The ability to effectively navigate in a hybrid environment is itself a skill and therefore a source of power. Hybridity requires employees to be ambidextrous — able to balance between and navigate across both worlds — in a way that fully co-located or fully remote working don't.

Employees who are strong at relationship building, both face-to-face and virtually, have an advantage in hybrid environments, as do those who are willing to ask for, find, and claim the resources they may not

have easy access to. Employees with good network and political awareness are able to recognize advantageous positions and situations, and those who establish strong relationships that can transcend the gap between face-to-face and remote working can use informal connections to replace missing information. Hybrid environments reward employees who think and act adaptably and flexibly, who are able to organize and coordinate across a complex and dynamic environment, and who are able to establish and provide evidence of their own trustworthiness when working in a context of low visibility.

On the other hand, employees who are less effective at building relationships in either in-person or remote environments may find themselves struggling to work with collaborators who do work that way. Those who are less skilled at coordinating work within such a complex system may find they're constantly out of sync with colleagues and managers.

Hybridity competence is a separate source of power from hybridity positioning. Someone in a disadvantaged position may still be able to work very effectively if they have high hybridity competence, while someone in an advantaged position may still be ineffective if they have low hybridity competence.

The Managerial Challenge

While employees need to ensure that they're visible to their managers and can access the resources they need for their work, managers similarly need to make sure they stay informed about what their employees are doing and facilitate their access to those resources.

Managers who are co-located with their employees have more information about what and how those employees are doing. Managers who are remote from their employees may feel like they're operating in the dark. Incomplete information is nothing new,

but hybridity's real threat is to fairness. Here are four ways managers can actively manage the structurally inevitable differences in power that arise in a hybrid environment and their effects.

Track and communicate. Create an accurate map of your team's "hybridity configuration": who is working where, and when. Once you've mapped this out, you need to have a conversation with them to surface the challenges they and you face and discuss what you can do to overcome them. Always bear in mind that your employees' resource access depends on their location, and their visibility depends on their location relative to you.

Making this task more complex is that hybridity is itself dynamic — a result of variations both across employees ("Martine works in the office, Mark works from home") and for individual employees ("I work in the office MWF and at home TT"). This makes hybridity a moving target. It requires ongoing systematic tracking, codifying, and visualizing to help both managers and employees stay aware of the configuration of hybridity in a given work group and manage the resulting power dynamics.

Design. While some level of power imbalance is structurally inevitable in a hybrid team or work group, when necessary and possible, managers should intervene to redistribute power through shifting access to resources and/or visibility levels.

At the same time, policies and procedures should be revisited regularly to ensure they don't provide an unfair advantage based on hybridity — for example, KPIs that don't align with resource accessibility, or evaluations that don't account for differences in visibility levels.

Educate. Many of these issues arise not solely from hybridity itself, but from a lack of awareness of the power imbalances it creates. To effectively manage

in hybrid environments, managers must promote awareness of the issues and educate employees (and themselves) on how to avoid bias.

Particularly important is establishing a culture of psychological safety and (individual/collective) trust. This will increase the likelihood of employees speaking up and asking for resources when they need them, as well as their confidence that their efforts will be recognized.

Monitor. With this understanding in mind, it's important that managers keep an eye out for key intervention moments. Through our discussions with executives, we've identified a number of key opportunities to address the potential challenges of hybridity for power dynamics within their teams:

Performance reviews and evaluations. Managers must remain acutely aware of how hybridity creates an imbalance in their teams with respect to employees' access to resources and visibility levels, as well as the information that they hold about their employees. Reviews present an opportunity for managers and employees to review and discuss imbalances and how to address them going forward.

Team launches. Hybrid teams start with team members who are not on the same footing. Team launches are an opportunity for managers and team members to recognize, acknowledge, and discuss power differences and to decide how collectively to manage them.

Onboarding. How can managers bring people into the organization when not everyone can physically come to the office? How can they put their new remote hires on a comparable footing to those who are brought into a face-to-face office environment? Hybridity's impacts on group dynamics need to be incorporated into onboarding sessions and discussions in order to ensure new employees recognize the importance of consciously managing hybridity-based sources of power.

For companies to reap the many benefits of hybrid working, managers must be aware of the power dynamics at play. It's critical that they develop an understanding of hybridity positioning and hybridity competence and take steps to level the playing field for their teams.

What's Behind the Pay Gap in STEM Jobs?

Women are paid less than men for entry-level positions — and it has nothing to do with their skill sets.

Among the many devastating impacts of the coronavirus pandemic is the stark fact that working women have been disproportionately affected — with four times more women than men being pushed out of the labor force, according to one survey. As the pandemic erodes women's progress in the workforce, addressing the inequalities they face from the start of their careers becomes ever more critical, beginning with equal pay.

Unfortunately, however, when it comes to working in engineering and tech — fields that offer the fastest growing and highest-paying jobs — an entry-level salary for a man is more than \$4,000 higher than what's paid to a woman with comparable credentials. So begins a salary gap that only widens over time, shrinking

women's savings and extending their debt burden.

Stanford researchers who studied this disparity discovered that there is in fact one credential that separates these new hires: self-confidence. Where one candidate guarantees he can prototype and problem solve, the second

candidate expresses her doubts. Employers in engineering and computer science fields appear to offer higher starting salaries to applicants who present as self-assured, and those applicants are mostly men. This new research is the first to identify a link between confidence and a pay gap at the start of engineering and computer science careers.

“We see students who have taken four or five years of hard classes, some have done internships, but our data implies that employers are so swayed by the confidence with which these 22-year-olds are expressing what they can do,” says lead author Adina Sterling, an associate professor of organizational behavior at the Stanford Graduate School of Business.

I Believe, Therefore I Can

Overall, the team’s findings point to the hefty role that self-efficacy — a person’s belief in their capabilities — plays in persuading an employer which job candidate will be successful as an engineer, and which will not.

“Confidence is not the same as competency,” says study coauthor Sheri Sheppard, a Stanford professor of mechanical engineering. “If you’re judging somebody based on projected confidence, you’re losing out on hiring individuals who are going to be doggone good at the work.”

Backed by a grant from the National Science Foundation, the researchers surveyed 559 engineering and computer science students who graduated from more than two dozen U.S. institutions between 2015 and 2017. They found that women earned \$61,000 in their first jobs compared to \$65,000 for men, despite having the same degrees and grade point averages.

According to the subjects’ answers to questions about their capabilities, the researchers concluded that 2% of the pay gap between men and women could be explained by a gap in self-confidence.

Compared to their male counterparts, women in the survey applying to engineering and computer science jobs reported feeling less sure of themselves when designing a new product or project, conducting experiments, building prototypes and models, as well as other skills hiring managers look for in potential employees. Yet, in actuality, these women possessed the same skills as the male applicants.

The Rising Toll of Losing Confidence

Data has shown that confidence in girls plummets in high school math and science classrooms, even as girls take as many credits as boys — and earn slightly higher grades, according to a 2007 report by the U.S. Department of Education. In addition, girls in high school and college are more critical of their math skills and hold themselves to higher standards. At Stanford, Sheppard notes, the top female students in her engineering classes describe feeling inadequate — also known as the imposter syndrome — every day.

That lack of self-confidence, prior to the Stanford study, had not been linked to early pay discrepancies. And its impact is significant: “The transition from school to work is unique in that if people can get on the right track, it propels you,” Sterling says. Which means that when women start out \$4,000 behind their male counterparts, catching up is nearly impossible.

Sterling and her colleagues have a hunch as to why women end up with smaller paystubs. Women are less likely to negotiate a salary than men. And hiring managers may funnel women to lower paying positions. “Sometimes these career decisions are incremental,” says Sterling. “If you interview and then you get the job, you become an engineer. If you don’t, maybe you become a lower paid lab technician.”

The confidence gap can steer some women out of engineering and computer science fields altogether, positioning them to make even less. Women who go into education, for instance, earn up to \$20,000 less annually than they would as an engineer, Sterling says.

Mind the Pay Gap Through a Growth Mindset

But her research and others’ may offer female job applicants in STEM fields a leg up. Stanford psychology professor Carol Dweck found that when a girl believes she can learn what she needs to know in science and math, she is more likely to succeed in a STEM field than if she believes

a person is born with skills in those subjects. Professors can foster this growth mindset in their female students.

By contrast, Sheppard suggests that men risk feeling overconfident, and she hopes colleagues in engineering departments teach students more balanced self-reporting. “How do people learn to be right confident, the appropriate level, and represent themselves and their capabilities?” she asks. The goal should be that they “not oversell themselves.”

Recruiters also need to reevaluate how they evaluate candidates, Sheppard says. Employers may want to observe applicants performing tasks they’d need to do on the job.

Next, Sterling is studying how internships influence the gender pay gap. Preliminary evidence suggests that when women are given the chance to try out for an organization as interns, they receive higher starting salaries.

“Women are, in a lot of ways, told to discount their own opinions of themselves and to think about everybody else’s opinions of them,” Sterling says. But simply suggesting that women should be more confident doesn’t fly in her book.

Women would never choose to enter a job interview feeling hesitant, Sterling says. “Imposter syndrome is a horrible feeling.”

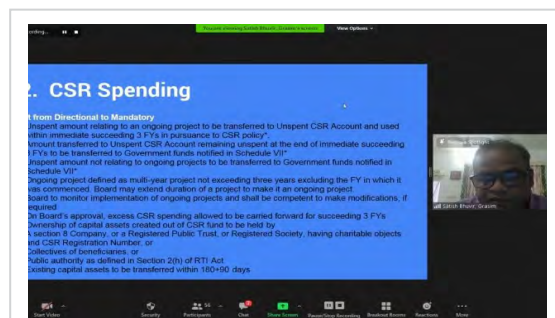

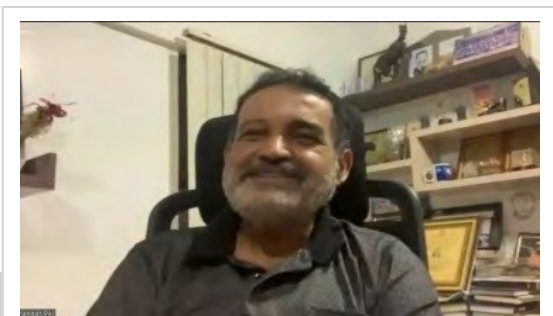

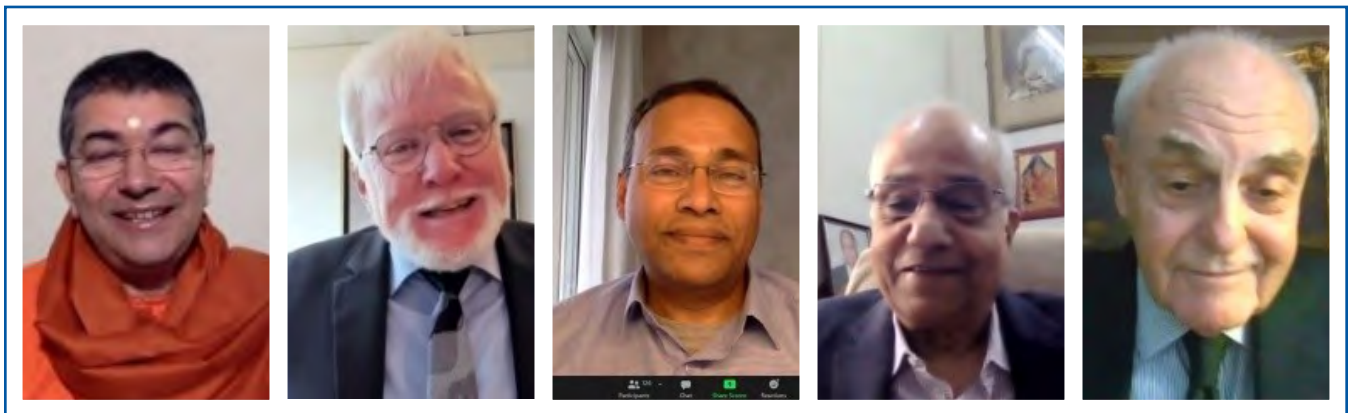

Union Budget Analysis Meeting 2021

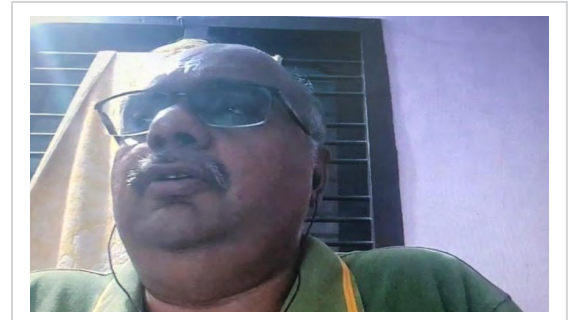

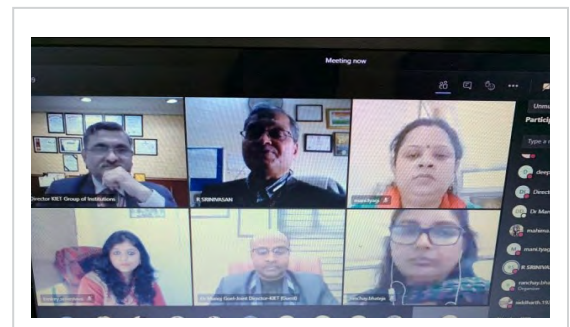

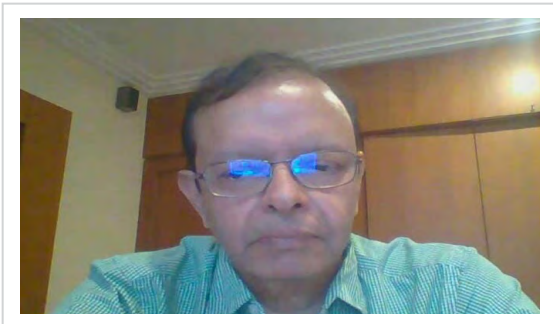

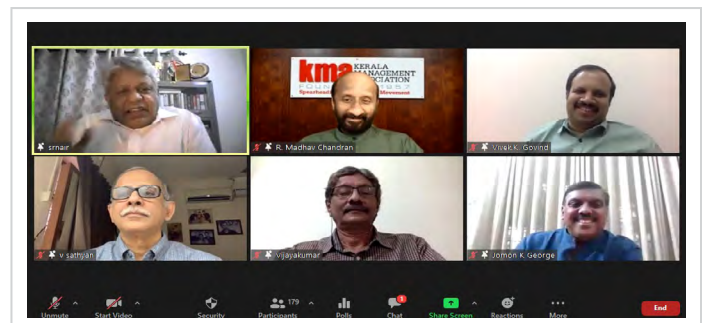

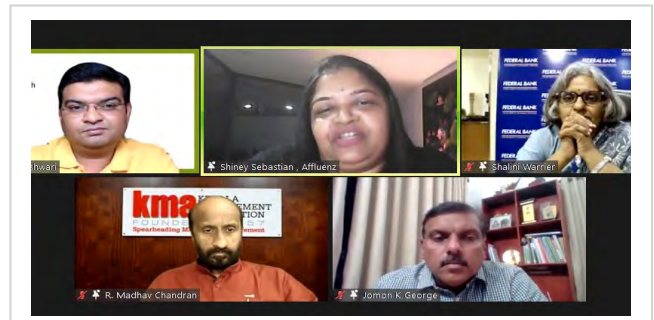

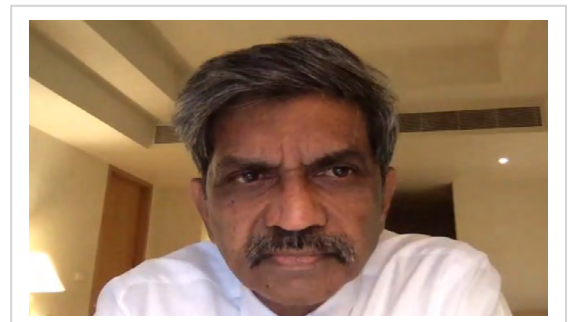

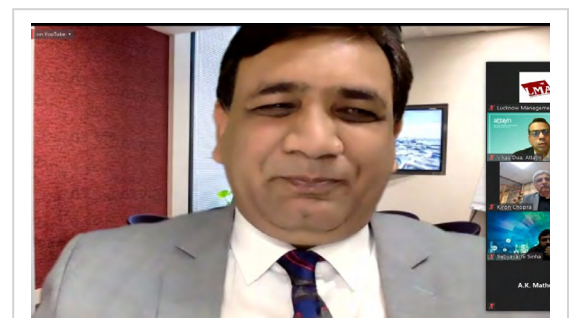

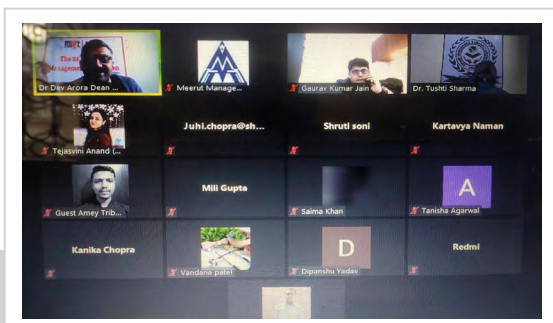

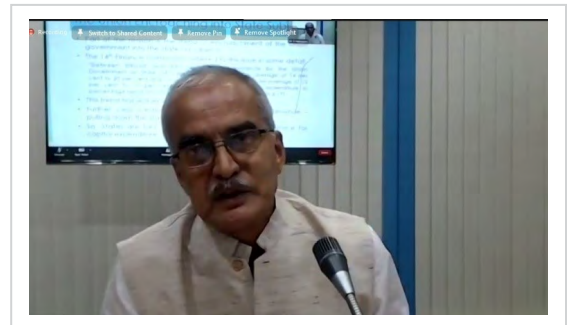


PMA addressing National Management Day

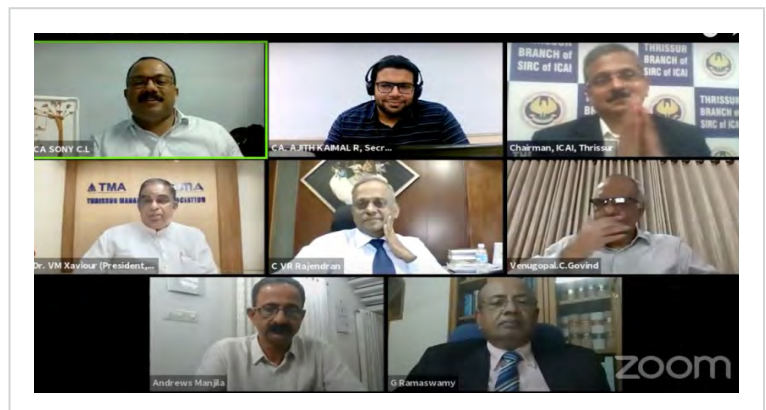

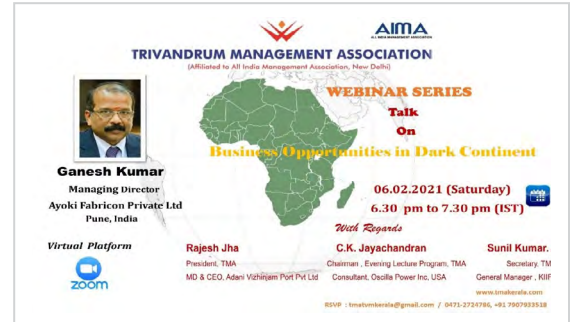

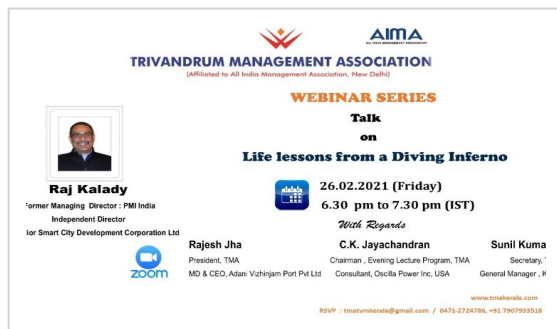
