AIMA also continued with its hugely popular LeaderSpeak Series during the period. A series of webinars with thought leaders including industry captains, spiritual gurus, senior government functionaries including ministers and bureaucrats, were conducted on topical themes and subjects – many of them seeing participation in thousands of members. In addition, AIMA successfully launched its hugely popular Management Aptitude Test (MAT) in the 'Internet based Remote Proctored Test' (IBT) mode. With the introduction of the IBT mode, candidates now also have the option of giving the test from home, which is remotely proctored using Al based tools and human proctors. Remote Proctoring will be extended to many of AIMA's other offerings including yearend examinations of Universities and B Schools – including AIMA's own end of the term examinations held by its Education Division and also for Company recruitment tests etc.

In another first, AIMA organised a Virtual Conference of Vice Chancellors, Provost, Pro Chancellors and Directors on the theme 'The Emerging Online Education, Post Covid 19'. The Virtual Conference was addressed by Mr Sanjay Kirloskar, Mr Sunil Kant Munjal, Prof Rajan Saxena, Prof Bhimaraya Metri and several other renowned academicians and corporate leaders. With an aim to build a network of University leaders in online education, AIMA also announced the formation of its Vice Chancellors Council. The vision of the Council is to build a world class online Management Education and facilitate the transition of Indian universities to world class institutions.

AIMA's Young Leaders Council also kept its members engaged, and several online sessions with industry and thought leaders were conducted over the month. During the period AIMA continued to offer its Education Courses, MDPs, Workshops & Trainings for both management practitioners and students. Further details are carried inside along with brief reports from the LMAs and some interesting articles on management.

These are challenging times for Indian management with an uncertain future ahead. Not just India, but the entire world is grappling with the long term effects of the coronavirus pandemic. To keep one step ahead, organisations like the All India Management Association, and the Local Management Associations need to come forward and help Indian managers reinvent current management practices and techniques as per the new normal, to emerge stronger on the other side.





Internet based Remote Proctored Test mode launched for MAT

Now students can take MAT from home!



To facilitate B-school admissions during the Corona Pandemic, AIMA recently launched based Remote Proctored Internet Test mode (IBT) for AIMA's MAT May 2020, where students can take exams from safety of their home. IBT mode was launched smoothly and successfully as per schedule on 25th May 2020 in two sessions; with eighteen more sessions to follow in the next four weeks. While the student community was looking forward with characteristic enthusiasm to take MAT through this 'Anytime-Anywhere' option from the safety of their own homes; the B-School management too were, understandably, anxiously awaiting its kick-off. At a time when most high stakes exams have been rescheduled to July or even later,

due to the crippling COVID-19 pandemic; AIMA conducted MAT in multiple IBT sessions in May 2020, in line with its original schedule.

Mock tests have also been scheduled by AIMA to help candidates familiarise themselves with the IBT process and the test environment. All that the candidates require to take MAT in IBT mode are a computer with webcam and microphone and internet connectivity; both conforming to certain basic technical specifications. The security and credibility of the test are ensured by the availability of robust internationally tried and tested Artificial Intelligence (AI) based software as well as trained and experienced personnel for effective remote proctoring.





Going Bananas


Driving back every morning, after a walk in the park, loften stop en route to pick up 6 bananas from a roadside vendor. It is usually twenty-five rupees irrespective of the size and quality of the fruit. We keep a little money in the glove compartment and as our vehicle gets close to the cart, my wife takes out couple of tenners & the vendor quickly gives us the potassium rich plantains.

This morning, there were no ten rupee notes. So she gave him a fifty. As we moved on, I thought I had seen her collect only one note from the vendor & shove it into the glove compartment. Just to cross check if she'd got back twenty-five, I asked. Despite her annoyance she opened the compartment and sure enough there was only one ten rupee note.

I reversed the car and told the vendor what had happened. He said sorry and handed over another fifteen; at the same time making a light hearted comment "Ho jayega chaalis ka bhi shayed hamari hi life main" (It will become forty, perhaps in my own life time) I laughed it off at that time but it did set me thinking later.

I was reflecting on the price of this highly nutritious poor-man's fruit over the years. I remember that it sold for 6 annas a dozen (appx 20 paise for 6) in the mid - fifties. So in sixty years it's gone up by 125 times. And I'm not even factoring in the better varieties on good fruit shops and in super markets where you could easily shell out Rs 80/90 per dozen. Now, I can't think of any other goods or services where the cost has gone up in that proportion. At least none of the other fruits has escalated so much; apples may be 20 times, grapes even less, oranges forty... even vegetables – despite all the hue and cry - perhaps none has multiplied hundred fold. One thing does come to mind. Again a poor man's necessity - the lowly post card - that used to cost all of 2 paise (1/32 of a rupee) is now one rupee! (Actually I am not sure if that is correct) So here is another case of 32 fold appreciation. Still can't beat the banana in the inflation sweepstakes. There are of course some banana competitors. Motor fuel – that life line of the nation that moves every commodity including foodgrains. If I remember correctly price of this black gold has also risen over the last sixty years – from 12 annas (75 paise) a litre to Rs 65, nearly 90 times! Same thing holds good for kerosene and LPG also. Ironically it does not hurt only the well off owners of motorcars but also the poor man on the street. His potatoes & onions are transported by trucks & everytime the fuel prices rise, the poor man's budget goes haywire. How would they ever come above the poverty line. They'll never be able to afford the mandatory 2000 calories per day if the prices keep going up in geometric progression.

Yes, a 'mundu' who cost Rs 50 in the 50s is now Rs 3000 per month, but



Be a Data Custodian, Not a Data Owner

"Data is the new oil." In the years since mathematician Clive Humby coined this phrase in 2006, the idea has taken on new meaning. For businesses today, personal data is not just a resource — it is a core profit-driver. But the value placed on "drilling for data" has come with a high price at the human level: a dangerous mindset of data entitlement, whereby companies collect personal information and use it to make money, with little regard to the people who lent it to them in the first place.

Data entitlement puts a business's reputation and customer trust at risk. It can be immensely expensive, as companies such as British Airways and Marriott learned firsthand when they were fined hundreds of millions of dollars following major data breaches, under the General Data Protection Regulation (GDPR), the data privacy regulation implemented by the European Union in May 2018. The personal information being leaked is not just a collection of files stored on a server somewhere; it amounts to the intimate 22 details of peoples' lives.



While data may still be the new oil, businesses can no longer view it as an asset to be extracted and exploited. The reality is that no company owns customer data — rather, customers entrust them with it. Instead of thinking like "data owners," companies must act as "data custodians" who protect personal information and use it only with a customer's best interests in mind.

Becoming a data custodian does not require expensive infrastructure changes or writing a single new line of code. Often, irresponsible data use is cultural — fixing it involves weaving data custodianship into employees' day-to-day processes. Four cost-effective tactics can help any business get started:

Create a Data Accountability Report

A monthly or quarterly "data accountability report" is a simple and effective way to promote transparency and peer-accountability around personal data use. The report can be straightforward, listing how many customer records each employee or team has accessed in the past month or quarter. Making someone's actions visible is a proven method for changing human behavior — just look at how step counters have encouraged people to be more active.

To be clear, accountability is not about shame or blame; instead, it is about empowering employees with knowledge. Simply seeing how many times they have accessed personal data compared to colleagues can make them think and act differently. Distribute reports without rankings, commentary, or judgment.

Celebrate Less Data Use and Analyze Responsibly

Flip the data owner mindset on its head by

celebrating the teams that access the least amount of personal data to perform their jobs. For example, if an engineering or customer service team has not accessed personal data in weeks, yet still managed to get its work done effectively, acknowledge their accomplishment and make it a rallying point for the organization. Invite them to showcase their strategy to the company over a team lunch. What are they doing differently to avoid the need for data access? Are there tools and techniques that other teams should learn about? These discussions can help to find new best practices and reinforce that privacy is a priority.

To be sure, being a good data custodian sometimes means sharing valuable insights from your data with customers so they can make more informed decisions. There are a few guidelines to ensure you're analyzing data responsibly: aggregate, anonymize, and don't surprise. Examine broad sets of anonymized data, which can surface valuable insights while respecting customer privacy. And consider how customers will react to the insights — they trust you with their data, so handle it with care.

Pair Employees for the Most Sensitive Data Access

Sometimes, solving a customer problem can require accessing very sensitive information, such as Social Security numbers. In these situations, which should be rare, it can be helpful for employees to pair up and access a customer's record together. Pairing up reduces the likelihood of intentional data misuse as well as human error. If a colleague enters the wrong tax ID into a system by mistake, for example, a partner will be there to catch it. This solution is free from a technology standpoint and only requires extra employee time. Again, the message is not that



you don't trust your employees, but that you value peer accountability and support.

Establish a Privacy Committee

An organization-wide privacy committee can bring internal stakeholders together to make decisions about a company's data culture and policies. It can also create space to dig into privacy issues — especially those without clear, industry-standard guidance. Imagine you are an executive at a food delivery business. You need to decide the company's policies for sharing consumer information with restaurants on the platform. For instance, a deli may want customer addresses for marketing purposes, but probably doesn't need this information to fulfill orders. A privacy committee can talk through situations like these and set standards for the company and the industry.

Privacy committees generally consist of leaders from Marketing, Legal, Security, Engineering, Design, and Customer Care. Beyond job function, ensure that the committee is multifaceted. Privacy means different things to different people based on their backgrounds, and a homogeneous group has more blind spots than a diverse one. Leaders with the same life experience and worldview are more likely to overlook privacy concerns — for example, seemingly benign features of an app that could be used to racially profile, stalk, or harass specific groups of customers.

Remember the Human Behind the Data

Drilling for data can seem like a limitless source of profit, but trust is the real resource that businesses should be mining. When a consumer shares their personal information, they should trust companies to use it with their best interests in mind. The organizations that succeed in the coming years will be those that build longterm, trusted relationships with customers by humanizing data and taking responsibility as its custodians.

Jeffrey Pfeffer: COVID-19 Changes Everything — and Nothing — about Managing Workers

For employers, best practices during a pandemic are no different than before: take care of your people.

One result of all of this being at home: Multitasking is now the new normal. A CEO who has children ages three and six told me that she (with help from her husband) was simultaneously running a company, a daycare center, and a school. But expecting individuals to do their jobs with the same level of concentration and performance is insane. "People are finding it harder and harder to get things done" — and for good reason. Not only are they tackling tasks in dif-



ferent work environments (likely with fewer interactions with bosses and colleagues), they are trying to do so while being bombarded with dire updates about health outcomes and the state of their retirement accounts.

When I went looking for advice about how to manage workers through what is, one hopes, a temporary albeit highly stressful situation, I was struck by how many of the recommendations seemed like general best practices. Here's what I heard from a handful of companies navigating this new work/life reality.

Try to Avoid Layoffs

Job loss raises the risk of premature death by 63%, negatively impacts both physical and mental health, and about doubles the suicide rate. But is it possible to retain employees in such difficult economic times? Of course it is — because layoffs are, in part, a choice. They are also a consequence of how leaders run their business. During the 2008 recession, for instance, Whole Foods laid off fewer people than Stanford University, which has a multibillion-dollar endowment. After 9/11, Southwest laid off no one, unlike its peers in the airline industry.

More recently, in response to the COVID-19 pandemic, 24 Hour Fitness laid off every one of its 30 director-level people, GMs and area managers, according to a former employee. In most cases, the layoffs were effective immediately — with few people getting even 90 days of severance and most getting nothing. Meanwhile, Lifetime Fitness, a private equity-owned competitor, announced that all of its C-level folks would work for no pay so that layoffs could be avoided, according to that same source. As you can imagine, sidestepping layoffs allows companies to retain talent that can spring into action when things recover. (As that former 24 Hour Fitness employee wondered, "Who is going to run the place when they reopen?") It also generates gratitude and extra effort from the team. Jim Goodnight, cofounder and CEO of software company SAS Institute, which avoided layoffs during the 2008 downturn, noted that employees found ways to save money and enhance productivity once they felt secure. Taking care of your people is always a good idea.

Prioritize Wisely, Define Urgency, and Provide Backup

Too much of organizational life is filled with busy work, unnecessary meetings and forms and processes that don't add value. But a crisis is a great time to redesign how we work. One reason for the crazy hours that have become all too customary (and are mentally and physically detrimental to our health) is that we believe "everything is equally urgent" — even though, of course, it is not. Better prioritization helps employees focus on what matters most (both personally and professionally) and clears away distractions, setting them up for greater success.

In practice — and in response to COVID-19 — that might mean immediately putting all of the long-term, non-critical projects (like completing 360-degree performance reviews) on the back burner so that people can focus on the most mission-critical tasks. In fact, that's exactly what Sarahjane "SJ" Sacchetti has done as CEO of Cleo, a company that offers virtual support and resources to those "on their journeys through life as parents."

But shifting priorities alone isn't enough. Employees often feel under the gun because some critical task falls squarely on their shoulders. (No wonder people often work while sick.) Under Sacchetti, Cleo changed the system of individual accountability, so that for important projects, there were at least two people — and frequently more — who shared responsibility. That way, if pressing issues came up in their lives, they could easily cover for one another. Not only does this provide a sense of support among workers, but it ensures that important tasks are always completed.

Embrace the Connection Between Work and Family

Pretending children don't exist during business hours was never a realistic solution. "Every day is 'Bring Your Child to Work Day' because that's what's on employees' minds," Sacchetti says. "While they're at work, parents are thinking about daycare pickup, the fact that their child has a behavioral issue, how they're going to create a nutritious meal." This precarious balancing act has been made more apparent by the pandemic, but it's long been an issue that companies have failed to adequately address. A report from the Center for American Progress noted that 90% of fathers and 95% of mothers experienced work-family conflict, which studies show leads to greater absenteeism, more turnover, reduced labor force participation (particularly for women), and reduced productivity. The COVID-19 crisis is a perfect time to finally remediate family leave, paid time off, and other policies that could smooth the divide — and lead to better outcomes for both individuals and companies.

Assess How People Are Doing

Without data, it is impossible to manage anything, including employee well-being and engagement. That's why it's critical to be smart about gathering feedback. Recently, Gallup published five "pulse" survey questions that any company can use to make sure they're meeting the needs of their workers during this crisis. If management is failing to properly communicate or build confidence among employees, they can rethink and test out new strategies and practices before soliciting more feedback down the road.

Meanwhile, global design company IDEO instituted a tracker so they could identify the whereabouts of employees — whether they were at home, caught in a remote location, or staying with other family members — to better support them in their work. Armed with that knowledge, the company was able to provide equipment (at no cost to the employee) as well as social support and referrals to mental health professionals. In general, assessing people's well-being and checking in on them is a clear signal that an organization cares.

Unleash Their Creative Energy

Now is potentially a great time to challenge employees to reimagine processes that have been done a certain way "just because." (Think of all those wasted hours at unproductive meetings.) IDEO's Head of HR, Duane Bray, for example, shared that the company crowd-sourced ideas from employees for how it could move its mostly in-person design research methods online. Encouraging workers to think outside the box may well lead to superior business solutions that can simultaneously make everyone's lives easier.

Reducing economic insecurity and stress, eliminating non-value-adding activities, giving people back-up, recognizing employees' familial responsibilities, assessing how workers are doing (and providing support), and examining the possibility of working in new ways are all sensible suggestions. Not just during the COVID-19 crisis, but all the time. In that sense, the current health crisis changes nothing about what good leaders and good companies should always be doing. It just makes those actions more urgent.
