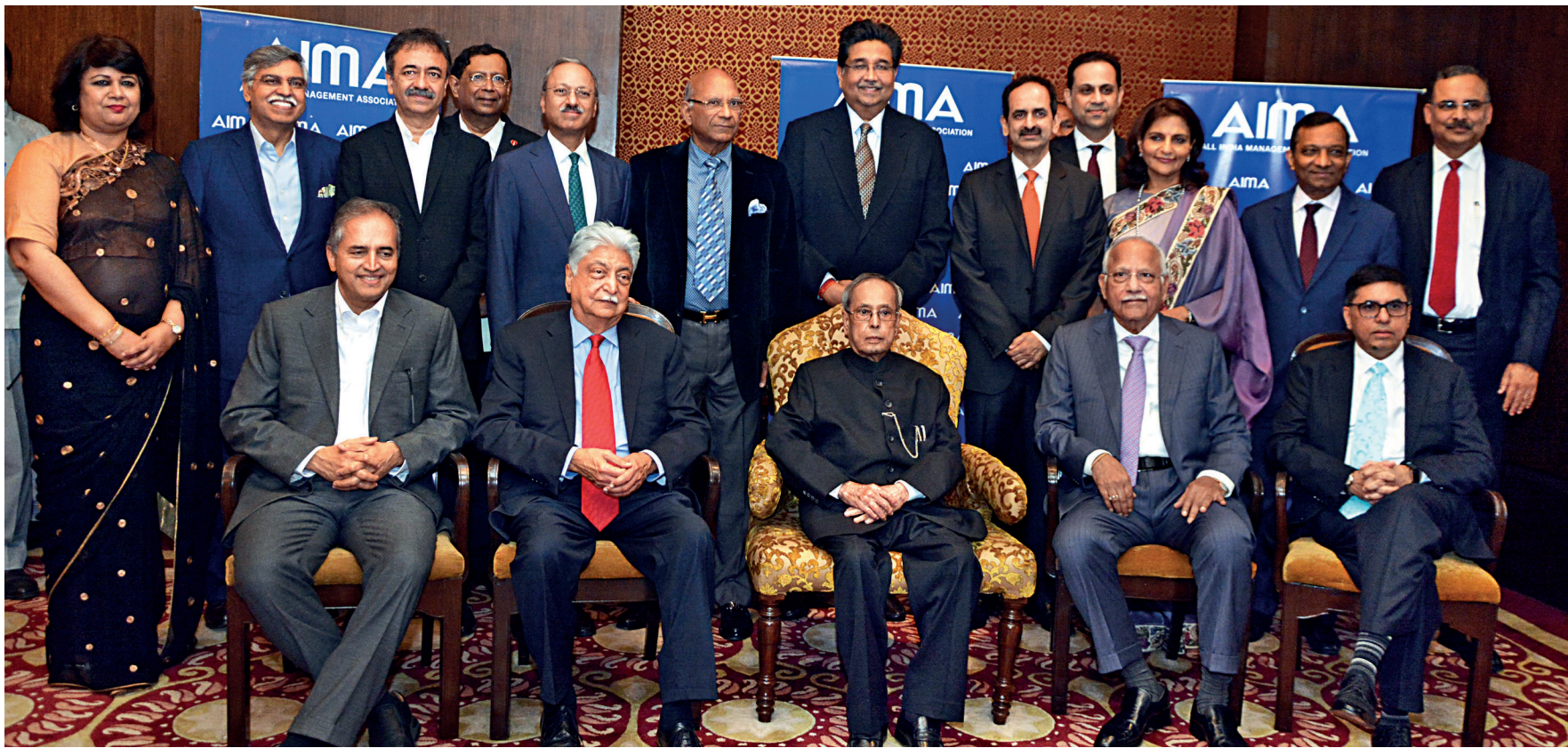


HONOURING THE PIONEERS OF CHANGE

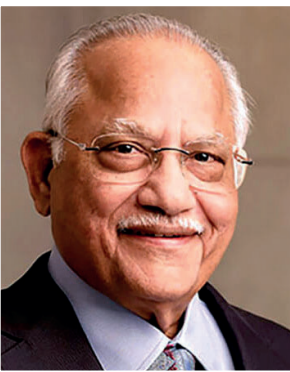
